If your revenue is below \$50,000 and you submit a postcard 990, you MUST attach Board/Committee financial statement for your most recently completed TWO fiscal years. The program financial statement must include program revenue, including contributed and earned income and income realized from investments, as applicable, and expenses.

**For non-arts organizations:** attach a Board/Committee approved arts-specific program financial statement for your most recently completed TWO fiscal years. The program financial statement must include program revenue, including contributed and earned income and income realized from investments, as applicable, and expenses. In-kind is not included.

### For Fiscally sponsored entities'
